For the purpose of this risk assessment, we have used the term 'coronavirus' to refer to coronavirus disease 2019 (COVID-19).

Schools must comply with health and safety law, which requires them to assess risks and put in place proportionate control measures. Schools should thoroughly review their health and safety risk assessments and draw up plans for the autumn term that address the risks identified using the system of controls set out below. These are an adapted form of the system of protective measures that will be familiar from the summer term. Essential measures include:

- a requirement that people who are ill stay at home
- active engagement with NHS Test and Trace when requested

An outbreak, as defined, is whichever threshold from the following is reached first:

- 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period; or
- 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period
- For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time: 2 children, pupils, students and staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period

Schools should have in place a reporting procedure for positive cases, and a contingency plan. Additional measures identified (in conjunction with Public Health) must be included as part of the school's infection prevention and control risk assessment as part of ongoing review.

#### System of controls

#### We will always

1. Ensure good hygiene for everyone. 2. Maintain appropriate cleaning regimes. 3. Keep occupied spaces well ventilated. 4. Follow public health advice on testing, self-isolation and managing confirmed cases of COVID-19

- 5) engage with the NHS Test and Trace process if required
- 6) contain any outbreak by following local health protection team advice
- Numbers 5 to 6 must be followed in every case where they are relevant.

We will regularly review and update our risk assessments – treating it as 'living document', as the circumstances in our school and the public health advice changes. This includes having active arrangements in place to monitor whether the controls are effective and working as planned.

We have outbreak management plans outlining how we would operate if there were an outbreak in our school or local area. This plan is to revert back to elements our risk assessment last reviewed in June 2021 with students being placed back in bubbles. These will include: Enhanced cleaning regimes, students moving around school by taking routes out of the building, enhanced testing and the resumption of wearing face coverings. Given the detrimental impact that restrictions on education can have on children and young people, any measures in our school will only ever be considered as a last resort and for the shortest amount of time possible.

• In preparation for January start Howden School will offer all students onsite **Testing through a booking system on Microsoft Teams- Uptake levels indicate that we do not need to** stagger the start of the school term. All staff and students should test over the holidays in line with national guidance. This means that they should test if they will be in a high-risk situation that day and before visiting people who are at higher risk of severe illness if they get COVID-19. Staff and students have been informed through a letter

## Timeline for January 2022 return

Parents and Carers advising in December of expected mitigations in place for January 2022. Review current covid levels both nationally and locally

Check DfE updates for current advice as well as ASCL and PHE

If necessary meet online with TCAT estates manager to discuss mitigations

If required apply mitigations and communicate to staff and students via letter that is highlighted in a email and text sent to accompany the letter. The least level of mitigations are the plans we have in place know.

On 11/10/2021 we broke through the 10% threshold of cases in school and so we introduced mitigating factors such as: Enhanced cleaning regimes, students moving around school by taking routes out of the building, enhanced testing and the resumption of wearing face coverings in communal areas and on transport to and from school. Following discussion with PHE on 13.10.2021 we have implemented the following measures, Sports fixtures temporary suspended to avoid across site contact. This is in line with other local schools, Temporary suspension of classes after school that are not directly related to GCSE studies, Review meeting in 7 days with PHE, Wearing of face masks in changing rooms while getting changed for PE. Year 7/10 daily LFT at home. Issue LFT tests to all students in Y10 and Y7 so they can test every day for the next 10 days

If we have several confirmed cases within 14 days, this may be outbreak. We will call the dedicated advice service who will escalate the issue to our local health protection team where necessary and advise if any additional action is required, such as implementing **elements of our outbreak management plan**.

## January 2022 contingency and updates

## Changes to the self-isolation period

Since Wednesday 22 December, the 10-day self-isolation period for people who record a positive PCR test result for COVID-19 has been reduced to 7 days in most circumstances, unless you cannot test for any reason.

Individuals may now take LFD tests on day 6 and day 7 of their self-isolation period. Those who receive two negative test results are no longer required to complete 10 full days of self-isolation. The first test must be taken no earlier than day 6 of the self-isolation period and tests must be taken 24 hours apart. This also applies to children under five, with LFD testing at parental or guardian discretion. If both these test results are negative, and the person does not have a high temperature, they may end their self-isolation after the second negative test result and return to school from day 8.

The DfE has stated that children now need to wear face coverings in classrooms as well as communal areas. This is to help keep schools open and will be reviewed on January 26th. The guidance states that schools should "have a small contingency stock of face coverings available if an individual has forgotten or damaged their own". We do have these, but as stated in my previous email we will need to start using our behaviour policy for the small number of students who are continually not looking after their masks or not wearing them around the building. It is the child's responsibility to bring a mask to school and to look after it. We already have a list of pupils who are exempt and will share this with staff.

#### Additional contingencies:

- Introduce 2 metre gap in all class rooms to separate students from staff
- Reissue guidance to TA's regarding working with students
- Limit numbers of staff in offices and staff room, this is noted on the door of each space
- Where possible students to walk around the outside of the building in between lessons
- Introduction of staggered lunches for both canteens- information shared with students on Wednesday 5th of January
- Daily review of staffing to ensure we can continue to offer school based learning.
- Staff briefings limited to staff with items for agenda

If staffing drops but not to a point where we cannot continue with school based learning:

- Combine classes where possible
- Create combined class space in hall so that 2/3 classes can be educated together in same year group with iPad to support learning
- Use additional capacity in school such as intervention tutors to take classes

If staffing drops to a point where we cannot continue with school based learning:

- Communicate situation with TCAT and seek additional support/capacity
- Prioritise on site learning for examination groups
- Communicate to parents/carers of affected year groups the learning will be online
- Use ICT audit to ensure all students in affected year group have access to ICT facilities and so can access online learning
- Retime table staff to prioritise learning for students left in school
- This will mean that learning will not be live for classes not in school but will be set on TEAMS
- CPD sessions will be limited to support all staff so they can upload lessons on TEAMS
